#### 3.1 Participants Statements

3.2 At the commencement of the event, Environmental Protection Director of Nangrahar **Mr. Aminullah Yousafzai** spoke and welcome, all participants of the event, beside he thanked FGA administration for organizing the event. He said that the National Environmental Protection Directorate of Nangrahar province have implemented a number of activities, as well as many programs in the field of public awareness, and have

a number of plans for the future as well. He also spoked round the effects of ongoing war on the environment from both national and international point of view and he described the negative effects of war on environment and said that the protection of the environment during war is responsibility of all of



involved sides in war. #### 5.1. Open discussions

**Group work** on international day for preventing the exploitation of environment:

A group work performed by participants about "current Environmental, Cultural and economic effects of war on our society" and what are the solutions for resolving these problems?, participants were divided into 2 groups and each of the groups wrote down their ideas about



the given problems in flipcharts and then one member of each group presented group work.

Each group express their concerns about current ongoing war in Afghanistan which it badly affected the environment, particularly considering the current socio-political and security situation. As well, as the public properties have been used and destroyed very carelessly by

war involved groups and fighters during war in instant most of our forests burnet and tries cut down houses buildings and roads were desperately destroyed, gardens, greenery and plants disappeared, water and air polluted, drought, Animal and plants happenings, destruction of cultivation resources. Etc.

Climate change, air and water pollution are very common issue and even we consider the pollution of voice environment at during war and arm conflict which impact on mind and psychological situation of hum.
